- Civilution Congress 2014 AEMU will be represented
- Eskom / Municipalities boundary issues mentioned
 - MOU needed first. SALGA / Eskom discussions to be held
- Surcharges report from SALGA on work in the area requested
- Certificate of Compliance Department of Labour failed to respond regarding damage by contractors to Municipalities cables
 - ECB produced Test report from Rustenberg Municipality. ECB need to "sell" idea to Municipalities

- General Machinery Regulation (GMR)is under review. Process halted due to review of Occupational Health &Safety Act. Waiting to hear if GMR review will now be recommended.
- Electricity Supply Bylaw:

Drakenstein to publish new revision by May 2014. Will be published on AMEU website.

- Public Administrative Management Bill to be discussed in Cabinet
- City of Cape Town (CoCT) Public Protector's outcome
 - CoCT had to pay out for damaged appliances
 - Ethekwini & City Power to challenge outcome
- Tariffs difficulty getting information from NERSA
 - NERSA focusing on resellers tariff; consultation paper by March 2014
 - IBT is <u>not</u> being reviewed. Suggest it is included in tariff workshop.
- Poor response to queries to NERSA
- Regulation R773 no blanket exception will be given
- Eskom MYPD3 process discussed
- Cost of upgrades to Municipal intake points by Eskom to be funded by operational funding. No response from National Treasury on this matter.
- Eskom's Alternative Municipality Tariff is out for comment.
- Annual tariff survey model to be simplified for easier comparison of electricity costs from different Municipalities.
- Update on Government Certificate of Competency results very poor outcomes. Attendance at classes is poor!
- AMEU to become custodian of Training Work Group
- Solar Water Heating programme covered
 - not a Department of Energy matter
- Pilots on Asset Maintenance (ADAM) programme discussed
- Regulation R773 sample letter for exemption from Ekrulaleni to be made available
- Approach on EDI position paper by SALGA covered

12. Update on Eskom's Integrated Demand Management programme (Joe Coelho)

- Load profile update given for summer & winter periods explained
- Generator maintenance is carried out mainly in summer which comes with its own risks to manage demand.
- May still need to develop an energy conservation scheme.
- Therefore "Live Lightly" this summer.

13. Reports from Government Departments / Terugvoering van Staats Departmente

13.1 Department of Local Government / Department van Plaaslike Owerhede (Joe Renney)

- MIG Infrastructure feedback given
 - Values specified, all funding was spent
- Thanks to all Municipality officials
- Master planning funding has been requested from National Treasury
- Capacity building reduction in training funding has occurred. This is regretted.
- George Municipality has taken training very serious and will be building a training centre
- Construction of Municipal buildings 62 buildings have been built to date
- Changes have occurred in Joe's Directorate at the Department of Local Government. CFO has moved to Stellenbosch. New CFO to be appointed.
- Joe advised that he will be retiring in January 2014 after 13 years' service with the Department.
 He thanked both Municipal officials, affiliates and consultants for all their co-operation over the past years.

Len Richardson proposed that Joe Renney be nominated for honorary membership of the AMEU in recognition of his services and assistance to the electricity departments of the Western Cape municipalities over the many years. The meeting seconded this proposal.

13.2 Department of Energy / Departement van Energie (Mhlangabezi Mzalisi)

- 2014/2015 to 2016/17 funding allocations
 - Provincial split allocations were presented for the 11 provinces
- Funding split given for Eskom areas vs Municipalities for these years
- Requests for funding received from Municipalities was given. This was much higher than the available funding
- Subsidy levels for next year were presented
- The five administrative challenges were listed as experienced in the past. The aim is to eliminate these challenges in 2014/2015

14. Compliance / Legislation

Dick Naidoo (Mossel Bay) raised the issue they experienced with their load management programme. They issue Compliance Certificates for geyser relay installations – He asked if this is necessary. After discussion it was concluded that this is not required in terms of Electrical Installation Regulations. Equipment belonging to Supply Authority is not part of electrical installation on a property.

Floris Mostert (Stellenbosch) stated that municipality electricians are not registered wireman therefore it is a problem if they work on private installations.

Michael Rhode (Knysna) stated that the Department of Labour exempts this if the installation is done in accordance with SANS 10142-1

- Signs available to warn that copper clad steel is used
- Compliance standards listed
- NRS 102 Theft deterrent standard is being developed in SA
- Corrosion resistance given. Long life possible without corrosion
- Connectors presented
 - Exothermic or clamps / crimp
- Durability and flexibility discussed
- Sizing and availability shown

16.3 "Now that we are vending – issues for consideration" – Thabiso Moiloa – Landis & Gyr

- To host or not to host Is that really the question??
- Technical expertise a problem in some municipalitiesy
- What is needed if a hosted system is used
- Consider the number of meters if you want to buy an vending system
- Can have a short term hosting contract
- Culture of non-payment is a factor for hosting
- Considerations to take account if you are to purchase your own vending system
- Vending outlets and payment options discussed
- Staff requirements are vital to consider
- Reports produced must be acted upon eg. low purchase reports
- For a hosted system:
 - if you have limited technical capacity
 - can be for a limited period until internal capacity is created
 - look into contract details!! Especially financial aspects (banking of money timeously)
 - Unrestricted access to run reports from the system for revenue management
- Proper meter management is vital

- Tariffs and fines must be in place
- System audit on vending systems are vital to ensure financial security

- Muniflex tariffs for Municipalities with >60% domestic consumers
 - Can this be applied to commercial consumers?
